Context

Under the Equality Act 2010 (Gender Pay Gap Information) Regulations 2017, businesses more than 250 employees are required to publish data about their gender pay and this report reflects the calculations required under this legislation.

Company

Plastipak UK Ltd operates within the manufacturing sector as a market leader in the production of PET preforms and bottles. The details contained in this report are based on data as at 5 April 2023. At this date Plastipak UK Ltd employed 247 people with 217 being male and 30 being female covering both our European Head Office and the Manufacturing Plant in North Wales.

Gender Pay Gap Calculations

These calculations are in line with the requirements of the UK Regulations which require the publishing of the following:

- The median gender pay gap
- The mean gender pay gap
- The median bonus gender pay gap
- The mean bonus gender pay gap
- The proportion of males and females receiving a bonus payment
- The proportion of males and females in each quartile pay band

Gender Pay Gap % and Gender Bonus Pay Gap %

The table below shows both the median and mean measures for both pay and bonus pay. The median represents the typical situation and is not distorted by small or large pay rates or bonuses. The mean is commonly known as the "average".

The mean gender pay gap for 2023 was -11.48% with a median of -1.26%

The mean bonus pay gap for 2023 was -19.05% with a median of -54.16%

The Proportion of Males and Females Receiving a Bonus Payment

The table below shows 94.5% males received a bonus compared to 100% of females. These numbers are influenced by eligibility and performance factors.

The Proportion of Males and Females in Each Quartile Pay Band

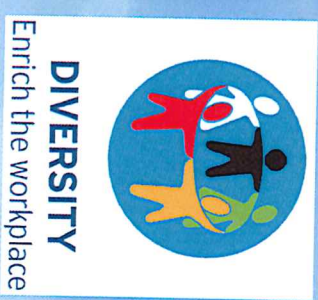
The table below shows females spread across all four quartiles. These numbers continue to be influenced by the difficulty of recruiting females into Manufacturing, particularly in the Production, Technical, Engineering and Management categories.
